1. INTRODUCTION

1.1 Subject of the technical conditions of the product.

The subject of the technical conditions of the product is ONLYECO Hand wash gel with antibacterial properties, hereinafter referred to as the product. The product is intended for cleaning and care of hand skin.

2. DESIGNATION

2.1. Designation. In accordance with the graphic design of the product packaging.

3. REQUIREMENTS AND TESTS

3.1 List of requirements and test methods – according to table 1.

3.2. Shelf life

When packaged, stored and transported in accordance with chapter 4, the product should retain properties provided in chapter 3.1 for 3 years from the date of production.

3.3. Quality control.

3.3.1. Batch composition. The batch is a specific number of product prepared for a single shipment in individual packaging of the same nominal content, packaged under the same conditions, at the same time.

3.3.2. Assessment of the test results. A batch of product can be treated as compliant with the requirements of the technical conditions of a finished product if the test results consistent with those provided in Table 1.

4. PACKAGING, STORAGE AND TRANSPORT

4.1. Packaging

4.1.1. Individual packaging – according to table no. 2

Deviations regarding the declared amount are regulated by the Attachment no. 2 of the Act on Packaged goods, as amended.

4.1.2. Outer packaging. Outer packaging is constituted by cardboard boxes protected from accidental opening by adhesive tape or paper adhesive-coated tape.

4.2. Marking

4.2.1. Marking of individual packaging. Each individual packaging of the product should have text of any graphic design containing:

- name and address of the manufacturer
- designation of the product in accordance with chapter 2
- ingredients
- product purpose
- best before (if applicable)
- batch no.
- content, ml
- cosmetic category

4.2.2. Marking of outer packaging. A label has to be placed on each outer packaging, containing:

- name and address of the manufacturer
- batch no.
- number of individual packages
- production date and storage period (if applicable)

4.3. Storage The product has to be stored in storage facilities which are dry, covered, ventilated, away from heat sources, at a temperature no lower than 8°C and no greater than 25°C. Number of storage layers – 11 layers. The product should be protected from direct sunlight.

4.4. Transport. The product should be transported via any means of transport which protect the product from soaking, soiling, sunlight and mechanical damage.
Number of loading layers – 11 layers.
